### **ANNUAL GENERAL MEETING**

This is a notice of the Thirtieth Annual General Meeting of the Communications and Media Law Association Incorporated (CAMLA) to be held on **Thursday 5<sup>th</sup> December 2024 at 5.45pm** at Gilbert + Tobin, Level 35, 200 Barangaroo Avenue, Sydney NSW 2000.

At the Annual General Meeting, the members will elect the office bearers and ordinary members of the CAMLA Committee for 2025. The Rules of the Association provide that any two members of CAMLA may nominate any other member to serve on the Committee. Nominations are required to be in writing and must be signed by the proposer, seconder and the nominated person. **Please note:** Committee members are elected in their individual capacities, not as representatives of their member firms or employers. As a nominee, you can't propose or second yourself. You need other individuals or corporate members to do so. A person signing for a corporate member may propose a nominee even if the nominee is covered by the same corporate membership. However, the seconder must be a separate individual or corporate member.

Nomination forms are available on the CAMLA website (<http://www.camla.org.au>) and must be lodged with the Secretary on or before **Thursday 28<sup>th</sup> November 2024** (*i.e.* seven (7) days prior to the Annual General Meeting). **Nomination forms can be emailed to [contact@camla.org.au](mailto:contact@camla.org.au)**

The Rules of the Association also provide that voting at the Annual General Meeting may be by proxy, provided that no member may hold more than 5 proxies. A form for the appointment of a proxy is also available at the CAMLA website (<http://www.camla.org.au>). Members wishing to vote at the Annual General Meeting by proxy should ensure that their completed form is lodged with the Secretary on or before **Wednesday 4<sup>th</sup> December 2024** (*i.e.* not less than 24 hours before the Annual General Meeting). **Proxy forms may be emailed to [contact@camla.org.au](mailto:contact@camla.org.au)**

**NB** Members are reminded that they must be currently financial in order to nominate a person for election to the Committee or to vote at the Annual General Meeting.
